This issue of the Vienna Law Review contains publications based on lectures given at the first Slovenian-Austrian Law Conference, which took place in Vienna at the Juridicum on 19 and 20 September 2019. The Slovenian-Austrian Law Conference is one of the results of a close cooperation agreement concluded between the Faculties of Law of the Universities of Ljubljana and Vienna in 2018. When we drafted this agreement, we thought of ways of bringing lawyers from both countries together on a regular basis as a cornerstone of said cooperation – and that is what actually happened during the conference.

Discussing the law with Slovenian colleagues is always a pleasure, as we can jointly address legal issues from a comparative, European and common perspective of both jurisdictions. This happy relationship with Slovenia continued when I became a professor, and for now almost 20 years, I have organised annual seminars together with my Slovenian colleagues Professor Aleš Galič and Professor Jerca Kramberger Škerl. So when I started my opening remarks at the conference with "It is a true pleasure ...", I actually meant what I said.

I would like to thank Professor Miha Juhart, who was an excellent vis-à-vis as a dean when we concluded the faculty cooperation agreement. His successor as a dean, Professor Grega Strban, led the Slovenian delegation to the Vienna conference and rendered outstanding services to the continuation of the cooperation. I am very grateful that my successor as a dean, Professor Brigitta Zöchling-Jud will continue to support our joint venture. Professor Jerca Kramberger Škerl and Mr. Boštjan Koritnik as well as Professor Claudia Rudolf, Ms. Lea Vouk, Mr. Žiga Škorjanc and Ms. Romana Mayer were instrumental for making the first Slovenian–Austrian Law Conference happen. Last but not least, Professor Franz Stefan Meissel had the excellent idea to publish these lectures in the Vienna Law Review. Thank you very much!
